## RBS International, Luxembourg branch

The below is an overview of general fees that apply to all accounts held in RBS International, Luxembourg branch. These new fees supercede any existing arrangements agreed by RBS International.

For clarity, this guide shows the main rates in euro (except where specified GBP), excluding Luxembourg VAT (where applicable) and are valid until further notice, reviewable annually. These charges are applicable from **Monday 5 August 2019**.

<b>eQ SEPA</b>	Low priority EUR payments between accounts held with banks in the SEPA area. Correct BIC and IBAN are mandatory, no special instructions for costs (e.g. "BEN" or "SHA").	€0.25
<b>eQ SWIFT</b>	International SWIFT payment sent via the SWIFT International payment network	€20
<b>eQ SWIFT - Euro</b>	SWIFT payment denominated in Euro sent within the EEA	€0.25
<b>Agents Charges</b>	Relates to Outward SWIFT payments when the sender wishes the beneficiary account to be credited in full.  NB. Not applicable for payments made within the EU/EEA	€15
<b>Account Transfers</b>	Payments between RBS International accounts in Luxembourg via eQ	Free of Charge
<b>Manual Payment</b>	Manual payments (internal and external) are provided by RBS International on an exceptional basis only. Please contact your Relationship Director for further information.	€100
